Lay Subsidies Staincliffe Wapentake

Lay Subsidies - taxes levied on the non-clergy to subsidise such as a foreign war. The earliest of any interest for Rimington and Middop are noted below. The Great Subsidy of 1524-5 is supposed to list all people over the age of 16 years with income from land or with taxable goods worth £2 per annum, or with annual wages of £1 or more. Each individual would be charged on the highest income earner, out of the three options, for the exchequer coffers. There are no ladies named bar for the very last entry in the Rimington 1547 return, the relict (widow) of James Oddye.
