By Lawmen [Another name for constables who served a one year term on a rotational basis; in Rimington it appears to have been every 5 years. Some years are missing. They were elected from the farmers and craftsmen of the township, and outside of it on at least one occasion. Some of their responsibilities would be collecting taxes and rates, keeping accounts and being responsible for the stocks, pillory, and the village lock up if there was one. All unpaid. They would also be responsible to the Head Constable of Staincliffe & Ewcross Wapentake in some instances and to the Justice of the Peace in others. The establishment of a national police force in the mid- 19th century brought this local means of enforcement to an end.]
